

NATIONAL CURRENCY DECREE 2026

Date & Decree Identifier: 2026-08-06 — M-B

ARTICLE 1

Section 1. This Decree shall be cited as the "National Currency Decree, 2026."

Section 2. By the powers vested in me by the Constitution of Solmeria, I, Sovereign Monarch of Solmeria (hereinafter "Monarch"), do hereby ordain this Decree.

ARTICLE 2 — ESTABLISHMENT OF THE SOLMERIAN CENTRAL CURRENCY

Section 1. The Solmerian Central Currency (hereinafter "SCC") is hereby established as the Official National Currency of Solmeria. It shall serve as the lawful medium of exchange in all matters of commerce, taxation, public expenditure, and lawful transactions within her borders.

Section 2. The SCC shall consist of the following denominations:

1. The Solmerian Dollar (symbol: \$; code: SCC), the standard monetary unit;
2. The Penny (1 Cent), equal to one one-hundredth (1/100) of a Dollar;
3. The Dime, equal to ten one-hundredths (10/100) of a Dollar;
4. The Fifteen, equal to fifteen one-hundredths (15/100) of a Dollar;
5. The Quarter, equal to twenty-five (25) Pennies;
6. The Half Dollar, equal to fifty (50) Pennies.

Section 3. This designation shall not be revoked or altered by any legislative bill or Council action. It may only be amended by a subsequent Royal Decree issued by the Monarch.

ARTICLE 3 — FORM AND ISSUANCE

Section 1. The exclusive authority to mint and issue the Dollar and its subdivisions is vested solely in the Ministry of the Treasury of Solmeria.

Section 2. The United States Dollar (USD) shall be recognised as a permissible secondary medium of exchange within Solmerian territory. No obligation to produce, mint, or issue USD is assumed by the Ministry of the Treasury or any organ of the Crown.

ARTICLE 4 — OFFICIAL EXCHANGE RATE

Section 1. The official exchange rate is fixed as follows:

SCC 1.00 (one Solmerian Dollar) = \$0.85 United States Dollars (USD)

Section 2. The Ministry of the Treasury shall monitor adherence to this rate. Should economic conditions warrant adjustment, the Monarch may issue a subsequent Decree revising the rate accordingly. The Ministry of the Treasury may not revise the rate on its own authority.

ARTICLE 5 — MERCHANT AND INSTITUTIONAL OBLIGATIONS

Section 1. Every merchant, institution, and private party engaged in commerce within Solmeria shall accept the Dollar as valid payment. This obligation is not subject to waiver or exemption.

Section 2. The United States Dollar may additionally be accepted as payment where both transacting parties give their express and mutual consent.

Section 3. Any seller who refuses tender of Dollars from a willing buyer shall be deemed in violation of national commerce law, subject to the following enforcement process:

1. Any subject, merchant, or institution may report a violation to the Ministry of the Treasury;

2. The Ministry of the Treasury shall investigate the report and refer substantiated violations to the Courts of Solmeria;
3. The Courts of Solmeria shall determine and impose a monetary fine upon a finding of violation;
4. Any party found in violation may appeal the finding to the Courts of Solmeria under standard appellate procedure.

ARTICLE 6 — PROHIBITION OF COUNTERFEITING

Section 1. The unauthorised reproduction, forgery, or fraudulent imitation of the Dollar or its subdivisions in any form is strictly prohibited.

Section 2. Any person found to have produced, distributed, or knowingly circulated counterfeit currency within Solmerian territory shall be subject to prosecution and penalties as prescribed by the Courts of Solmeria. This Article applies only within the territorial jurisdiction of Solmeria.

ARTICLE 7 — EXCEPTIONS

Nothing in this Decree shall prevent the Ministry of the Treasury from withdrawing damaged, defaced, or counterfeit currency from circulation, nor shall it be construed to require acceptance of currency reasonably suspected to be counterfeit.

ARTICLE 8 — ENTRY INTO FORCE

This Decree shall take effect immediately upon its signature by the Monarch and shall remain in effect unless expressly superseded by a subsequent Royal Decree.
