

EXECUTIVE ORDER NO. 1

ORDER OF DISSOLUTION OF THE DEMOCRATIC REPUBLIC OF NEW BURLINGTON

By the authority vested in me as President of the Democratic Republic of New Burlington, pursuant to Article III, Section 4 and Article VII of the Constitution of the Democratic Republic of New Burlington, I hereby issue the following Executive Order:

Article I — Dissolution of the Republic

Section 1 — Declaration of Dissolution

The Democratic Republic of New Burlington ("DRNB") is hereby formally dissolved as a political entity effective immediately upon the date specified in this Executive Order.

The authority to issue this Executive Order is granted under Article VII, Section 1 of the Constitution, which provides that the President possesses the constitutional authority to dissolve the Democratic Republic of New Burlington.

Section 2 — Effective Date

The dissolution of the Democratic Republic of New Burlington shall take effect on:

July 8, 2026

Upon this effective date, the governmental institutions of the Republic shall cease to operate.

Article II — Termination of Governmental Institutions

Section 1 — Executive Offices

The offices of President and Vice President of the Democratic Republic of New Burlington shall cease to exist upon the effective date of dissolution.

Section 2 — General Assembly

The General Assembly of the Democratic Republic of New Burlington shall be dissolved.

All legislative authority previously granted under the Constitution shall terminate.

Section 3 — Constitution and Laws

In accordance with Article VII, Section 3 of the Constitution:

- The Constitution of the Democratic Republic of New Burlington shall become null and void.
- All laws of the Republic shall expire unless preserved by a receiving sovereign authority.
- All governmental powers previously exercised by the Republic shall terminate.

Article III — Transfer of Authority

Section 1 — Sovereign Recognition

The dissolution shall be carried out in accordance with the authority recognized by the Kingdom of Solmeria.

Upon completion of this dissolution, the Kingdom of Solmeria may recognize the Democratic Republic of New Burlington as dissolved in accordance with the Royal Decree authorizing the dissolution.

Section 2 — Government Records

All official records, documents, archives, and governmental materials of the Democratic Republic of New Burlington shall be transferred to the custody of the designated authority of the Kingdom of Solmeria for preservation.

Article IV — Final Declaration

The Democratic Republic of New Burlington is hereby declared dissolved.

No further action by the General Assembly, referendum, or other governmental body shall be required, as Article VII, Section 5 grants the President exclusive authority to complete the dissolution unless the Constitution is first amended otherwise.

This Executive Order shall serve as the final legal instrument dissolving the Democratic Republic of New Burlington.
