

ROYAL DECREE OF THE FEDERATED KINGDOM OF SOLMERIA

TITLE

Decree Ratifying the Constitution of the Federated Kingdom of Solmeria and Transitioning the Kingdom's Governance

PURPOSE

This Decree formally ratifies the Constitution of the Federated Kingdom of Solmeria, retires the prior governing instruments, and directs the transitional actions necessary to bring the Kingdom's governance into immediate alignment with the new Constitution, pursuant to Article XIV and Article XIII of that Constitution.

IT IS HEREBY DECREED:

- 1. Ratification.** The Constitution of the Federated Kingdom of Solmeria, as signed by the Sovereign Monarch, is hereby ratified and takes full legal effect immediately upon the issuance of this Decree.
- 2. Renaming of the Realm.** The realm formerly known as the Kingdom of Solmeria is hereby renamed the **Federated Kingdom of Solmeria**. All prior references to "the Kingdom of Solmeria" in existing Decrees, laws, and records shall be read as referring to the Federated Kingdom of Solmeria.
- 3. Retirement of Prior Instruments.** The Royal Charter of Solmeria, the Governing Charter of Solmeria, the First Constitution of the Kingdom of Solmeria, and the Second Constitution of the Kingdom of Solmeria are hereby retired as governing instruments of

Solmeria, effective immediately, and are preserved solely as historical record. No provision of any retired instrument may be relied upon as current law.

4. Continuity of Decrees. All Royal Decrees lawfully issued under any prior governing instrument remain in full force, except to the extent any such Decree contradicts the Constitution of the Federated Kingdom of Solmeria, in which case it is void only to the extent of that contradiction.

5. Continuity of Parliament. All persons who held a seat in Parliament immediately before this Decree retain their seats in Parliament under the new Constitution without interruption or need for reappointment.

6. Continuity of the Council of Ministers. All ministerial appointments in effect immediately before this Decree remain valid under the new Constitution unless and until the Monarch issues a new appointment Decree.

7. Continuity of the Judiciary. Any Constitutional Tribunal, Supreme Court, or equivalent judicial body previously constituted is hereby succeeded by the Crown Tribunal established under Article VI of the new Constitution. Any pending matters before a prior judicial body shall be treated as pending before the Crown Tribunal.

8. Redesignation of the Federal Layer. Any States, Territories, or equivalent subnational bodies admitted under a prior governing instrument are hereby redesignated as **Provinces** under Article XII of the new Constitution. Any Federal Assembly of the Union or equivalent body previously constituted is hereby redesignated as the **Council of Provinces**. Each such body retains its existing standing, membership, and any adopted charter, which shall be treated as its Provincial Charter until amended to conform fully with Article XII.

9. Directive to Update Records. The Council of Ministers is directed to update all official records of Solmeria to reflect the Kingdom's new name, the ratified Constitution, and the redesignations in Sections 6 and 8 of this Decree, within thirty (30) days.

10. Effective Date. This Decree is effective immediately upon issuance.
